Minutes of August 20, 2009 Meeting

The meeting was called to order at 7:02 a.m. by Pastor Ken Thiele.

Meeting minutes: from July were reviewed and approved as submitted. Dwight and Clem motioned, Team approved.

Treasurer's Report: \$1,785 income from Tornado Days leaving a balance of \$3,248.36 cash on hand. The Bake sale brought in \$427 and Thrivent matched with \$107. The Lions and Fire Hall donated money for garbage collection. Clem and Dianne motioned, team approved a \$50 donation also towards the garbage hauling. We are still unsure if we owe all or a portion of the \$700 radio ads.

Directory: Current supply is nearly gone. Keri has updated all files and the last 500 copies will be printed.

Throws / Blankets: to date we have broke even on costs. \$1,225 / 35 have been sold. The second order of 30 is in at Viking Bay Resort. Dianne will be giving some to different locations / mounting them on curtain rods or hangers for better showing. She will also keep tally on them all.

Habitat for Humanity: one possible candidate is working with Ken Thiele at this time..

Community Center sign: temporary sign from the Lions should be put outside and put the website name on it..

Chamber of Commerce / Advertisement: A review of the After Hours newsletter and the Wake Up Alex. Newsletter should be done. Someone should check on the cost for a weblink on the Chamber web directory. Plan for the Wake up Alexandria at the MCC in April.

Breakfast Fund Raiser: tabled until September meeting. A committee of Pastor Keri, Gen, and Dick will get together to plan. They are to talk to the school for dates and Lenten events. Plan on a Saturday in January or February.

Tornado Days Review: Clem passed along Thank You's for a great day and great turnout. Great weather helped.

Buttons: Print the website and number on the back next year. Increase number to 750. There were 43 prizes; 10 are left unclaimed. New numbers were drawn and will be posted on the website.

Draw the numbers at a bigger event time; earlier in the weekend. Then list the numbers ahead or throughout the weekend.

Banners: need one for the crafters, church service and one for the waffle feed.

Radio ads: the radio station pulled the wrong year information, we still own \$700, but Keri will try and work with them to pay only ½ due to their error. Motion by Clem and Curt to pay \$284 to KXRA and \$160 to Kool, \$250 to KIKV. Keri will negotiate with Kool and KIKV. Curt to talk with KXRA.

Larger Tent: to hold guest bands to highlight them more or rope off area in the Pavilion.

Antique Car Show: should be investigated again.

Safety issue: possibly blocking off the street from the Liquor Store South

Halloween Party: Saturday, October 31 afternoon or early evening. Also do Treats for the Troops. Curt will check with Lisa and the school to see if they will still be running it. Clem to get information on the website. Committee to coordinate: Ken Thiele, Dianne, and Kathy.
